Special and/or Sensitive Personal Data

Purpose of Processing Personal Data

Go Social Studios processes your personal data for the following purposes:

- To respond to your inquiry

- To contact you by phone or email if necessary for service delivery
- To inform you about changes to our services or products
- To deliver services or products to you

Automated Decision-Making

Go Social Studios does not make decisions based on automated processing that have legal or significant effects on individuals. We use standard website tools (such as WordPress) solely to manage our site and contact forms, without any profiling or decision-making automation.

Data Retention Period

Go Social Studios does not retain your personal data longer than necessary for the purposes it was collected.

We apply the following retention periods:

- **Contact form submissions:** kept for up to **12 months** after the last contact, unless further communication requires ongoing storage.
- **Email correspondence related to services:** retained for up to **7 years**, as required by Dutch tax law and administrative regulations.

Sharing Personal Data with Third Parties

Go Social Studios only provides data to third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Cookies and Similar Technologies

Go Social Studios uses only technical and functional cookies, as well as analytical cookies that do not infringe on your privacy. A cookie is a small text file stored on your computer, tablet, or smartphone when you first visit this website. These cookies ensure the website functions properly and remember your preferences. We also use them to optimize our website. You can opt out of cookies by configuring your browser settings to refuse cookies. Previously stored cookies can also be removed via browser settings.

Accessing, Modifying, or Deleting Data

You have the right to access, correct, or delete your personal data. You also have the right to withdraw consent or object to the processing of your personal data by Go Social Studios.
